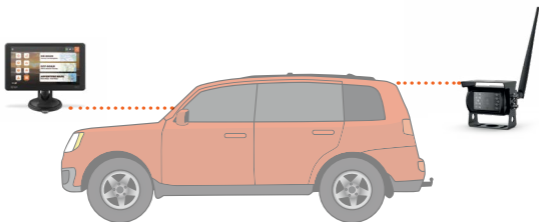
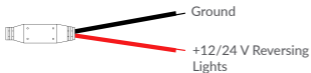

2.0 WIRING DIAGRAM AND INSTALLATION

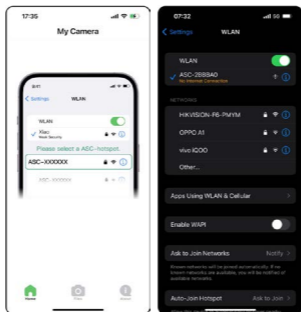
Please connect the rear camera power cable to the power supply of the vehicle as shown below.

Power Supply: 10V ~ 32V



3.0 REAR CAMERA CONNECTION TO HX-2+ GPS NAVIGATOR

1. After installing the rear camera, go to settings on the HX2+ and turn on WiFi, and connect to the following: ASC-XXXXXX (XXXXXXX being unique number).



2. When the rear camera is successfully connected with the HX-2+, it will be ready for operation.

PLEASE NOTE:

- The Wi-Fi video image from the rear camera will be visible once reverse gear is engaged and the app is activated.

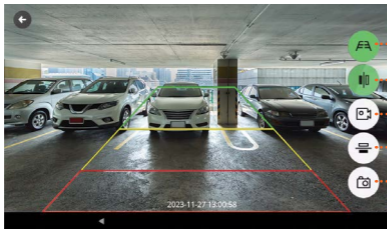
3. Turn on the HX-2+ and tap on the reverse camera icon on the screen interface.








PLEASE NOTE

- The rear camera view will only be visible when the vehicle is engaged in reverse gear.

- By default, the rear camera view displayed on the HX-2+ is a mirror image.
- You can change the image orientation by tapping on the relevant icons on the rear camera interface on the screen.

4.0 TROUBLESHOOTING

PROBLEM	SOLUTION

5.0 CARE AND MAINTENANCE

Always keep the camera clear of dirt and mud. Clean the camera with a soft moist cloth.

6.0 WARRANTY TERMS AND CONDITIONS

Our goods come with guarantees that cannot be excluded under the Australian Consumer Law. You are entitled to a replacement or refund for a major failure and for compensation for any other reasonably foreseeable loss or damage. You are also entitled to have the goods repaired or replaced if the goods fail to be of acceptable quality and the failure does not amount to a major failure.

This warranty is provided in addition to your rights under the Australian Consumer Law.
